SUMMARY ANNUAL REPORT FOR

GLAZIERS INDIVIDUAL ACCOUNT RETIREMENT PLAN

This is a summary of the annual report for Glaziers Individual Account Retirement Plan, EIN 94-6559783 for the year ended June 30, 2018. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by the Trust. Plan expenses were \$9,098,460. These expenses included \$247,214 in administrative expenses and \$8,851,246 in benefits paid to participants. A total of 4,017 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$144,653,957 as of June 30, 2018, compared to \$131,115,170 as of July 1, 2017. During the plan year the plan experienced an increase in its net assets of \$13,538,787. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$22,637,247, including employer contributions of \$15,027,712, earnings from investments of \$7,473,480 and other income of \$136,055.
